1. PAYMENTS Terms of credit are 15 days from statement date unless otherwise agreed upon in writing. Accounts not paid

within terms will be considered delinquent.

2. DEDUCTIONS

No deduction on payment will be accepted without proper authorization.

3. INTEREST A delinquency charge of 1.5% per month (18% per annum) or maximum allowed by law, whichever

is greater, will be added on any amount which becomes past due more than 15 days from the net due date appearing on

each invoice and thereafter on delinquent amounts until paid.

4. CREDIT CLAIMS

Any quality problem must be reported within 24 hours of receipt of merchandise in question. You must receive a "control number" as proof A. of reported claim.

В. All sales are F.O.B. Miami and Continental Farms accepts no liability for damage in transit. Title and ownership are passed to the buyer when the flowers are delivered to the designated carrier. (Title transfer and pricing are unrelated issues.

All flowers must be INSPECTED UPON ARRIVAL. C.

- NEVER discard or destroy your problem flowers without proper authorization. We often request that they be returned at our expense. D.

- 5. COLLECTIONS In addition to all other charges and remedies, in the event of default in payment, Continental Farms

6. COURT JURISDICTION Any suit which arises from an extension of credit by Continental Farms, shall be

instituted and maintained in any court of competent jurisdiction in Miami-Dade

County and shall be governed by Florida Laws.
